**THE NEW SOUTH WALES BIRD ATLASSERS PUBLIC FUND - Donations

The principal purpose of the New South Wales Bird Atlassers Inc. (NSWBA) is to protect and enhance the natural environment within NSW and the ACT by recording native bird species, their distributions and habitats on a continuing basis, to undertake research thereon and provide information, educational material and publicly promote an awareness of each species' on-going status, needs and preservation.

In acknowledging the value of the NSWBA objectives on 19 August 1988 the Commonwealth Government formally recognised the NSWBA as a significant Environmental Organisation and we were then listed on the **Department of Environment's Register of Environmental Organisations.** Subsequently, the NSWBA was accepted as a Registered Charity under the **Australian Charities and Not-for-profits Commission Act 2012** and endorsed as a **Deductible Gift Recipient** by the **Australian Taxation Office**.

The NSWBA has established a public gift fund which is able to accept donations from any person or organisation. Donors of monetary or real property assets exceeding \$2.00 to the NSWBA Public Fund are entitled to claim a tax deduction for the amount of any donation in accordance with item 6.1.1 of sub-section 30-55 (1) of the Income Tax Assessment Act 1997. A Receipt can be issued, if requested.
