**** THE NEW SOUTH WALES BIRD ATLASERS PUBLIC FUND - Donations**

The principal purpose of the New South Wales Bird Atlassers Inc. (NSWBA) is to protect and enhance the natural environment within NSW and the ACT by recording native birds, their distributions and habitats on a continuing basis for research purposes. We provide information, educational material and publicly promote an awareness of each species' on-going status, needs and preservation.

In acknowledging the value of the NSWBA's objectives on 19 August 1988, the Commonwealth Government formally recognised the NSWBA as a significant Environmental Organisation and we were then listed on the Commonwealth's **Register of Environmental Organisations**. Subsequently, the NSWBA was accepted as a Registered Charity under the *Australian Charities and Not-for-profits Commission Act 2012* and was endorsed a **Deductible Gift Recipient** by the **Australian Taxation Office**.

The NSWBA has established a public gift fund which is able to accept donations from any person or organisation. Donors of money or real property assets exceeding \$2.00 to the NSWBA Public Fund are entitled to claim a tax deduction for the amount of any donation in accordance with under item 6.1.1 of sub-section 30-55 (1) of the *Income Tax Assessment Act 1997*.
